The June 8, 2023 meeting of the Shillington Borough Council was called to order at 7:30 p.m. by President John W. Hoffert. Following the invocation by Mayor Hivner and the oath of allegiance, roll call was taken. Council members in attendance were: John W. Hoffert; Michael A. Hoffert; Ronald R. Klee, Jr.; Edward B. Michalik and Conrad Vanino. Council members Elizabeth M. Bentz and Alec M. Ernst participated by telephone. Present in addition to the Council members were: Mayor Andrew R. Hivner, Borough Manager Scott D. Brossman, Fire Chief Robert Knouse, Solicitor Thomas Klonis and Secretary Jan M. Boyd. Kenneth Fulmer of Great Valley Consultants was also in attendance along with the following residents:

As there were no objections, the minutes of the May 11, 2023, council meeting were approved as forwarded to each member, on a motion by Mr. Vanino, seconded by Mr. Klee, and duly carried.

## PUBLIC COMMENT:

Mrs. Fake addressed Council regarding the number of cars that are out of inspection and parked on the street at Pearl and Franklin Streets. She and her husband own 29 Franklin Street. She believes that these cars are from the garages on Pearl Street that do work on vehicles. Chief Hivner will look into this matter.

Mrs. Fake also owns 222 Philadelphia Avenue. At this property, a neighbor's tree is hanging over this property. She questioned Solicitor Klonis what she could legally do in this situation.

Solicitor Klonis advised that she could remove any branches that are hanging over onto her property. However, he further advised that if possible, it is always better to work out an arrangement with the neighbor.

## COMMITTEE REPORTS:

Mayor - Mayor Hivner gave the Police Department's report for the month of May. During this month, the Department handled 259 incidents, with 95 arrests being made. Also during this month, 2,989 patrol miles were traveled.

Police and Personnel - On a motion by Mr. Ronald R. Klee, Jr., chairman, seconded by Dr. Michalik, and duly carried, Council approved the payment of $\$ 10,423.51$ in overtime paid to the members of the Police Department during the month of May.

Administration-Law-Finance - Dr. Edward B. Michalik, chairman, made a motion, which was seconded by Mr. Klee, and duly approved, to confirm payment of the bills associated with the May 31, 2023 Financial Statements, as follows:

    Fire - Mr. Michael A. Hoffert, chairman, gave the Fire Chief's report for the month of May. During this time, the Department responded to a total of forty-six (46)
dispatches consisting of nine (9) calls in the Borough and thirty-seven (37) assists to neighboring departments. Seven (7) training sessions were attended during the month.

The members covered 175.5 hours of 176 hours of the available daytime staffing for the month.

The Fire Department was authorized to paint the exterior of the Engine House at a cost of $\$ 13,500$ on a motion by Mr. Michael Hoffert, seconded by Mr. Vanino, and unanimously approved. Fire Department funds will be used to pay for this project.

Dr. Michalik then made a motion, which was seconded by Mr. Vanino, and duly carried, giving permission for the Borough's Fire Police to assist Cumru Township on Saturday, July 8, 2023 for the Greater Governor Mifflin League's Fireworks' Event.

Tree-Pole and Light - Mr. Alec M. Ernst, chairman, advised that the Tree Advisory Committee's spring planting was completed on May 15, 2023. The Committee is currently working on organizing the fall planting.

Streets-Sanitation-Water - Mr. John W. Hoffert, chairman, reviewed with Council the June Engineer's Report. He noted the following:
${ }^{\circ}$ As part of the Reed Street Water Main Project, the Welsh Road construction has been completed and the water main construction on Welsh Road and Church Road has been completed and tested. Water service piping for the Cumru Township campus is being constructed. The meter pit still needs to be installed.
${ }^{\circ}$ Rainbow Roofing has requested a change order for replacement of deteriorated roofing materials as part of the Roof Replacement Project at the Bathhouse. This change order will be presented under the Manager's report.

President Hoffert then gave the report of the Public Works Department for work done during the month of May.

Recreation - Mrs. Elizabeth M. Bentz, chairman, gave the minutes of the Recreation Board meeting held on June 5, 2023.

The first concert of the season was held on Friday, June 2, 2023 and featured The Uptown Band. Food trucks were available to the approximately 1,500 people that were in attendance. The next concert is scheduled for Friday, August 4, 2023.
